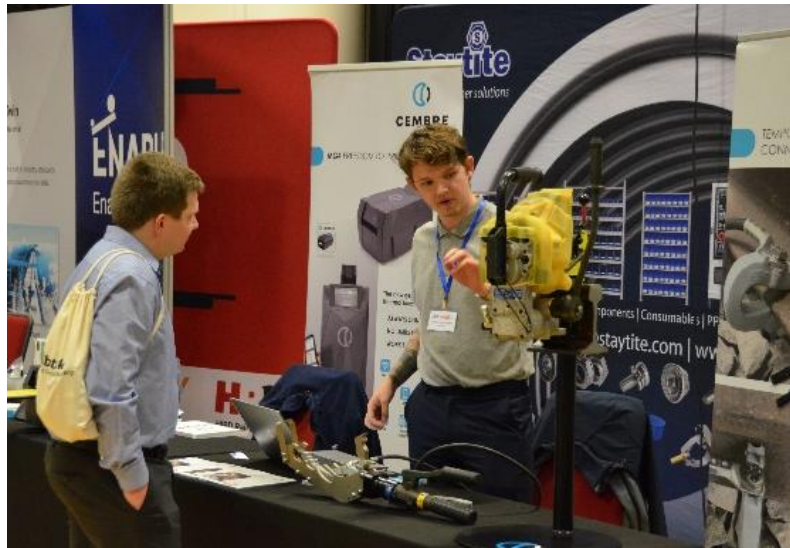

Terms and Conditions

(Sponsorship only)

These Sponsorship Terms and Conditions ("Agreement") are entered into between the sponsoring organisation ("Sponsor") and The Railway Industry Association ("Recipient") effective immediately.

1. Sponsorship Scope: The Sponsor agrees to provide sponsorship to the Recipient for the chosen RIA event according to the sponsorship package proposed by Recipient and agreed upon by Sponsor.
2. Payment: The Sponsor agrees to pay the sponsorship fee as outlined in the sponsorship package within 30 days from receipt of the Invoice.
3. Cooling-off Period: The Sponsor has a cooling-off period of 2 (two) weeks from receipt of this agreement during which they may request a full refund of the sponsorship fee.
4. Refund Policy:
 - a) If the Sponsor requests a refund within the cooling-off period and over 4 (four) weeks before the event, the Sponsor shall receive the sponsorship fee refund in full, and all evidence of the sponsorship will be removed.
 - b) If the Sponsor requests a refund within the cooling off period but within 4 (four) weeks of the event, the Sponsor shall receive a part refund of 50% of the sponsorship fee, as removal of the sponsorship will not be possible from event collateral.
 - c) After the cooling-off period, the sponsorship fee becomes non-refundable under any circumstances, including, but not limited to, cancellation of the Event.

These Sponsorship Terms and Conditions ("Agreement") are entered into between the sponsoring organisation ("Sponsor") and The Railway Industry Association ("Recipient") effective immediately.

5. Sponsorship Benefits: The Sponsor shall receive the benefits outlined in the chosen sponsorship package, subject to the terms and conditions herein.
6. Termination: Either party may terminate this Agreement upon written notice if the other party breaches any material term of this Agreement and fails to cure such breach within 7 (seven) days of receiving written notice of the breach.
7. Governing Law: This Agreement shall be governed by and construed in accordance with the laws of Jurisdiction. Any disputes arising out of or in connection with this Agreement shall be subject to the exclusive jurisdiction of the courts of Jurisdiction.
8. Entire Agreement: This Agreement constitutes the entire understanding and agreement between the parties with respect to the subject matter hereof and supersedes all prior agreements, understandings, negotiations, and discussions, whether oral or written, between the parties.
9. Amendments: Any amendments or modifications to this Agreement must be made in writing and signed by both parties.
